

## UFCW Joins Department of Labor and Mexican Embassy in Innovative Labor Rights Week Initiative

International President Joe Hansen joined the Mexican Consul General of Chicago, Manuel Rodríguez Arriaga, and local community leaders yesterday in Chicago to launch “Semana de Derechos Laborales,” or Labor Rights Week, a national outreach and education program.

Semana de Derechos Laborales is a partnership between the UFCW, the Embassy of Mexico, and the U.S. Department of Labor and allied organizations. The activities will continue through September 4 and will focus on the inclusion of Mexican nationals in American workplaces and communities. The program includes workshops and informational sessions on labor, immigration, and human rights.

“Our communities and neighborhoods are better, safer places to work and live when all workers know and exercise their rights,” Hansen said. “*Semana de Derechos Laborales* is a perfect way to empower Mexican national workers with information and promote full participation in the civic fabric of our nation. ## UFCW Challenges Walmart to Live Up to American Values

Executive Vice President and Director of Organizing Pat O’Neill today announced a new national comprehensive values-driven agenda to challenge Walmart to live up to American values.

The UFCW was joined by Nelson Lichtenstein, author of *The Retail Revolution: How Walmart Created a Brave New World of Business*; Kim Bobo, Executive Director of Interfaith Worker Justice; and a broad coalition of labor, consumer, environmental and community groups calling on Walmart to support core American values of worker rights, quality jobs, equal opportunity, corporate responsibility and a healthy environment.

“So we challenge Walmart to work with us---labor, civil rights, women’s, minority and faith organizations---to develop a code of conduct for Walmart to protect the rights of workers consistent with legal and human rights standards that promote the economic well-being of working families and communities,” said O’Neill.

“When a company gets to be as big as Walmart and employs so many workers – more than any other private enterprise in the world – it is no longer a ‘private’ entity,” said Lichtenstein, a professor of history at the University of California, Santa Barbara, and a leading expert on business, labor and politics.

“It sets the wage and benefit standard for every other mass retailer and influences the business practices of just about every firm in America’s huge service sector. So Walmart is part of this country’s debate: on health care, wages, equal employment, and the role of trade unionism in our democracy,” Lichtenstein added.

As a part of the launch, WakeUpWalmart.com is releasing two new TV ads calling on Walmart to offer quality, affordable health care coverage to all its employees.
